## **Protecting Patient and Staff Privacy**

During these extraordinary times, NYC Health + Hospitals remains committed to protecting patient privacy and confidentiality while we fulfill our mission to serve everyone regardless of immigration status or ability to pay. We know that staff are concerned for the health and safety of their friends and colleagues. However, accessing patient records for purposes other than treating a patient, or as necessary to fulfill official job responsibilities, remains strictly prohibited. In addition, any photography or filming of patients and staff requires express permission of the patients who are the subjects of such photographs. ### **Hotel Accommodations for Staff**

NYC Health + Hospitals is here to help employees during this COVID-19 crisis. The health system is now making hotel rooms available at no cost to employees in clinical and non-clinical roles, including affiliate and temporary staff. The rooms may be reserved for reasons that include self-quarantine, possible COVID-19 exposure, inability to return home for risk of exposing members of household, or other COVID-19 related reasons. ## **New COVID-19 Research and Evidence Digest**

The new Evidence Digest has plain language summaries of the latest evidence from the scientific and public health literature on the COVID-19 epidemic. Recent topics include briefs about the combination treatment of azithromycin and hydroxychloroquine for COVID-19, a new model from Harvard that predicts COVID-19 transmission, and the need

to include prisons and other detention centers in public health responses to COVID-19. The digest will be updated regularly.
